PNG Centre for Judicial Excellence

The Papua New Guinea Centre for Judicial Excellence (PNGCJE) coordinates judicial education and training for Papua New Guinea Judiciary, Magisterial Services, and Law and Justice Sector agencies. The purpose of the Centre is to facilitate and coordinate structured professional training to all judicial officers, court officers, and officers of the law and justice sector to help improve the delivery of judicial services to the people.

In 2023, the PNGCJE actively facilitated a range of judicial education and training programs. These initiatives were designed to enhance court excellence and promote better access to justice. The programs covered various critical areas of judicial education, including court practice and procedure, judicial administration and management, and substantive law.

The programs were conducted under the following PNGCJE/PCJE programs areas:

- a) PNG Judges and Magistrates;
- *b)* National Judicial Staff Services National and Supreme Courts;
- c) Magisterial Services District Court;
- d) Law and Justice Sector Agencies;
- e) Pacific Island Judges and Magistrates PCJE;

a) Judges and Magistrates (PNG)

Judicial education and training for judges and magistrates encompass a diverse range of components. that are designed to enhance the professional skills of judicial officers, optimize case management, deepen understanding of substantive law, bolster judicial integrity, and tackle current challenges. 2023 Judicial Education and Training Highlights

Anti-Money Laundering and Counter Terrorism Finance Training

The Anti-Money Laundering and Counter Terrorism Finance Training was organized by the PNG Centre for Judicial Excellence in collaboration with the United Nations office on Drugs and Crime and supported by the Government of Norway's International Climate and Forest Initiative. The workshop was facilitated to equip Judges and magistrates with ideas on how to address anti-money laundering and counter terrorism finance in the country. The workshop was attended by both Judges and Magistrates.

Whistleblower Protection Workshop

The Whistleblower Protection workshop was an initiative between the PNG Centre for Judicial Excellence and the United Nations Development Programme through the office of the UNDP Chief Technical Advisor, Dr. Alma Sedlar. The workshop was delivered not only to detect fraud, corruption and misconduct, but also to safeguard public interest and promote a culture of accountability and integrity. The whistleblowers training was part of the Preventing and Countering Corruption in Papua New Guinea Project (PNG Anti-Corruption Project) funded by the European Union and implemented by UNODC and the United Nations Development Project.

Managing and reporting Fraud and Corruption Cases

This week-long workshop brought together four court officers from the PNG Judiciary and thirty other Pacific Island court officers. This workshop took place at the Federal Court of Australia in Brisbane, Queensland. The event was jointly hosted by the Pacific Judicial Integrity Program and the PNG Centre for Judicial Excellence. Its purpose was to equip registrars, judges' associates, and other court officers with the necessary skills to effectively manage fraud and corruption-related cases. Notably, two facilitators from the PNG Judiciary, Ms. Victoria Belo (Assistant Registrar of the National Court) and Mrs. Stacey Levakia-Wali (PNGCJE Program Officer), actively contributed to the workshop.

Sir Buri Kidu Lecture Series

The Sir Buri Kidu Lecture Series is an annual event hosted by the PNG Centre for Judicial Excellence at the University of Papua New Guinea (UPNG). Each year distinguished guest speakers are invited to deliver lectures on diverse topics related to judicial administration and other related topics. The first SBK lecture in 2023 was presented by the former Australian Chief Justice Susan Kiefel on the topic of "Prerogative Writs and Modern Judicial Review: Constancy and Change." This lecture provided an invaluable opportunity for the public, and members of the law and justice sector to delve into the intricacies of international judicial systems. Beyond the lecture, participants engaged in networking, fostering connections with both their peers and the esteemed guest speaker.

Human Rights Defenders Training for Village Court Officers


The Human Rights Defenders course was designed and delivered in collaboration with the NCDC Gender Based Violence Secretariate and the Department of Justice and Attorney General. The training started on 9 October 2023 and ended on 13 October 2023. The purpose of the course was to educate
